2] TECHNICAL BID – COVER 1 :-

- b) All the details in the format shall be filled and signed by the Tenderer (Each page should be signed with company /firm seal).
- c) The price bid should be accompanied by the supporting documents, if any.
- d) The Price Bid should be quoted for exact equivalent product both in strength and all characteristics and applications and others if any quoted will not be considered.
- e) The tenders should keep the samples of Dyes and Chemicals for which they have quoted in the tender ready and they are in a position to send them within the stipulated period when asked to send for testing and evaluation. If any delay in sending the samples, the tender will be liable for rejection.
- f) Tenderer shall indicate the duties & taxes wherever applicable. While indicating the excise duty if any, sales tax and percentage of taxes on the basic price shall be indicated failing which it will be presumed that the rates tendered are net, F.O.R. destination Bahatti, Jamkhandi Taluk, Bagalkot District, Gadag-Betageri, Bhagyanagar, Koppal Dist., and Peenya 2nd Stage, Bangalore, Karnataka State delivery and no claims on this account will be entertained at a future date.

3 [B] RECEIPT OF TENDERS:-

2. No correspondence will be entertained once the tender has been submitted in response to the tender notice and no additional tender will be accepted.

3 [C] OPENING & SELECTION OF TENDERS:-

- a) **Technical Bid** will be opened by the authorised officials of the Corporation in the presence of tenderers who choose to be present at 11.30 a.m. on 24.09.2010. After the scrutiny and evaluation of the Technical Bid only those Tenderers who fulfils and satisfies with all the relevant documents and details only will be considered for the opening of Price Bid on 3.30 p.m. on 24.09.2010.
- b) The envelope carrying the Earnest Money Deposit draft and Technical Bid of the tenderers who have submitted Earnest Money Deposit would be opened. Bids not accompanied by Earnest Money Deposit even if opened are liable to be rejected. However, the right to accept/reject such tender/s will be at the discretionary powers of the MANAGING DIRECTOR of the Corporation.
- c) Samples if any submitted along with Technical Bid will be sent for testing, if necessary after coding for Technical & Chemical evaluation.

3 [D] VALIDITY OF THE OFFER AND DELIVERY SCHEDULE:-

Offer shall be valid 180 days from the date of opening the tender and rates tendered should be firm throughout the contract period i.e. execution of the purchase order in full as per the delivery schedule that will be indicated in the purchase order to be issued from time to time. Such delivery schedule may be postponed or preponed depending upon the requirement of the production units. No change in the terms of contract, as may be requested by the tenderers including rates shall be entertained during the tender contract period.

TERMS OF SUPPLY AND PENALTIES:-

- a) Orders will be placed on one or more tenderers whose tenders are accepted at the discretion of the Corporation, subject to compliance with the terms & conditions.
- b) Supplies should be completed as per the delivery schedule of the purchase order by the tenderer.
- c) Successful tenderer shall supply the dyes & chemicals as per the schedule mentioned in the purchase order.
- d) Each and every supply will be subjected to Lab testing. After testing, if there is any quality difference, the supply will be rejected and materials will be returned at the suppliers cost.
- e) The Corporation shall have the right to recover any loss that it may sustain consequent to any breach on the part of the tenderer/s to fulfill the terms of contract including failure to supply partially or/in full/irregular supplies, out of the EMD amount.

- f) The successful tenderer is responsible for proper packing/transportation of the dyes & chemicals to our concerned destination in good condition at their own cost and risk. Packing of Dyes & Chemicals should confirm to ISI standards.
- g) The KHDC Ltd., reserves the right to cancel the order with forfeiture of EMD if the supplies are not satisfactory as per the contract.
- h) Payment terms shall be by 30 days interest free credit from the date of despatch of material to Banahatti, Jamkhandi Taluk, Bagalkot District and Peenya, Bangalore subject to specifications being found as per the purchase order terms.
